Dear Nonprofit Friends,

All Grant, Catron, Luna and Hidalgo County nonprofits (who have their own 501 (c) 3 or have a Fiscal Sponsor), who intend to participate in Give Grandly! 2019, are invited to the **6th Annual Continental Breakfast** organizational meeting on **Wednesday, January 9, 2019 from 9 to 10:30 a.m. at Bear Mountain Lodge**. We encourage you to bring one or two of your **board members** so we can briefly share with them information about the Grant County Community Foundation.

The impressive success of ¡Give Grande! 2014 (**\$56,852**), Give Grandly! 2015 (**\$93,707**), Give Grandly! 2016 (**\$102,161**), Give Grandly! 2017 (**\$116,271**) and Give Grandly! 2018 (**\$159,516.46**) has resulted in total dollars raised by and for local nonprofit agencies over the 5 years of **\$528,508.66, exceeding our goal of \$500,000 in 5 years!**

The Grant County Community Foundation met twice with leadership from Give Grandly 2018 to talk about the Southwest New Mexico Nonprofit Coalition becoming more structured by incorporating in the State of New Mexico. The Coalition does not need to acquire their own 501 (c) 3, the Grant County Community Foundation will continue to serve as the fiscal sponsor. Incorporation will lend more legitimacy to the Coalition and will allow that entity to apply for grants, specifically matching funds for Give Grandly. We believe it will also be a feather in Grant County's cap, as there are no other associations of nonprofits in the State. We will be discussing leadership roles at this 6th Annual Continental Breakfast and Kickoff for Give Grandly 2019 and wanted you to have the chance in advance to think about restructuring to make the Coalition more effective.

The Give Grandly! 2019 event will be held as it has been the last few years on 7th Street in conjunction with the Silver City Farmers' Market's opening day, Saturday, May 11, 2019. Success for this event requires ongoing committee engagement and participation of all nonprofits who wish to be part of the event. We will have sign-up sheets on January 9th for you to add your name to the committee that you feel best matches your skill set.

The group has voted in past years that the participation fee would be **\$60.00**. This fee goes into the Southwest New Mexico Non-Profit Coalition's checking account, managed by you, and is used to pay for radio and print advertising for the event. The Grant County Community Foundation does not receive any portion of the fee. Last year the Foundation raised matching funds allowing us to add \$250.00 to the account of each nonprofit that raised \$250.00.

Each nonprofit is asked to complete the attached registration form and **bring the completed form and your registration fee of \$60.00** payable to SWNMNPC to the breakfast on January 9. If you cannot attend, or cannot bring it with you to the breakfast, please mail to SWNMNPC, c/o GCCF, P.O. Box 1767, Silver City, NM 88062. We will assume that organizations, who do not register by March 31, 2019, have opted out and therefore **will not** be included in any of the events planned around Give Grandly! 2019, or featured in any publicity. There will be no exceptions made to this deadline. This community endeavor is a collective opportunity to raise unrestricted funds for your organization. We need to focus on our mutual goal.
